Sumaiya Khair, Director of Research and Policy Division Mohammad Rafiqul Islam and Assistant Program Manager Nazmul Huda Mina were present in the press conference. The research report shows that, despite substantial progress in fulfilling the efforts of the stakeholder, many challenges still remain. Only a limited number of factories have adopted the process of forming safety committees even after six months of passing the rules. Procrastination and disinclination is seen in cases filed against the accused persons of Rana Plaza disaster and taking legal actions by some investigative organizations.

Significant challenges of good governance identified by the research report are, increasing production target in many factories, retrenchment of workers in helper rank without any legal assistance, harassing workers associated with trade union, lack of accountability in filing cases and discharging of duties, allegation of making labors work an extra hour without wage, failing to ensure security and prohibiting female workers to work at night. Dr. Iftekharuzzaman insisted upon transparency and accountability in his speech.






